A Few Reminders About Pools...

Drowning is the single leading cause of unintentional injury death in children under 5. If you plan to have children participate in water play this summer or if your day care program includes field trips to the local community pool, keep the following regulations in mind:

- 1. The use of spa pools, hot tubs and fill-and-drain wading pools is prohibited.
- 2. Barriers must exist to prevent children from gaining access to any swimming pool, drainage ditches, wells, ponds or other bodies of open water located on or adjacent to the property where the day care program is located. Such barriers must be of adequate height and appropriately secured to prevent children from gaining access to such areas.
- 3. The program must develop a plan of supervision which ensures that there is a person supervising the children in the pool at all times children are using the pool. The plan should be submitted to your licensor or registrar for approval. This plan must be shared with families served and permission for swimming must be given in written form.

Daily Health Checks

Daily Health Checks are a quick and easy way to ensure the health and well-being of the children in your care.

The Daily Health Check begins at the start of each day with a few simple questions when the child is signed into care.

"How is your child doing today?" "How did your child sleep last night?" "Is there anything I should be aware of?"

Additionally, the Provider must look for any indication of illness, injury, abuse or maltreatment and a record of the Daily Health Check must be kept and made available to the Licensor or Registrar if requested.

"I am having renovations in my home or my yard."

Call your Regulator!

"We have a new household member."

Call your Regulator!

"A child was seriously injured (burns, concussions, broken bones, etc.) while in my care."

Call your Regulator!

"There is a CPS Investigation in my home."

Call your Regulator!

"I will be going on vacation for more than two days" Call your Regulator!
